



Introduction and Methodology

From January 27 - February 2, 2025, DHM Research conducted an online survey of Washington residents. The purpose of the survey was to assess overall mood and economic outlook as well as residents' opinions on housing, AI, and local issues. This survey also explored residents' attitudes toward American values and gauged residents' impressions of prominent figures, major businesses, and facets of the criminal justice system.

Research Methodology

The online survey consisted of N=500 Washington residents and took approximately 15 minutes to complete. This is a sufficient sample size to assess Washingtonian's opinions generally and to review findings by multiple subgroups.

Respondents were members of a professionally maintained online panel. A variety of quality control measures were employed, including questionnaire pre-testing and validation. To ensure a representative sample, demographic quotas were set and data were weighted by age, gender, region, political party, education, and income level.

Statement of Limitations

Any sampling of opinions or attitudes is subject to a margin of error. The margin of error is a standard statistical calculation that represents differences between the sample and total population at a confidence interval, or probability, calculated to be 95%. This means that there is a 95% probability that the sample taken for this study would fall within the stated margin of error if compared with the results achieved from surveying the entire population. The margin of error for this survey is +/- 4.4%.

LOCAL ISSUES

Now, we have a few questions about policies currently being discussed by lawmakers in Washington.

In recent years, the Washington State Legislature has explored new revenue options to help fund transportation projects as gas tax collections have not been enough to cover rising maintenance costs. One of the reasons gas tax collections have not kept up with funding needs is due to the rising costs of road maintenance and the increasing number of fuel-efficient and electric vehicles.

One policy discussed by legislators is a retail delivery fee. Generally, a retail delivery fee is a fee imposed on the delivery of retail items delivered by motor vehicles in the state. At least two other states have implemented a retail delivery fee to help pay for road maintenance.
